WHAT IS COVERED

TEN YEAR WARRANTY

(ALL PARTS BESIDES CASSETES AND BELTS – LABOR NOT INCLUDED)

For the first ten years from the date of original purchase, when this machine is operated and maintained by the original owner and not for rental purposes. The machine must be used and maintained according to the instructions attached to or furnished with the product. Intelligent Harvest Systems will pay for factory specified replacement parts to correct non-cosmetic defects in materials or workmanship in that prevent function of this machine and that existed when this machine was purchased. This is a limited 10-year warranty on the above-named parts only and does not include repair labor.

TWO YEAR LIMITED WARRANTY (PARTS AND LABOR)

(ALL PARTS BESIDES BELTS)

For the first two years from the date of original purchase, when this machine is operated and maintained by the original owner and not for rental purposes. The machine must be used and maintained according to the instructions attached to or furnished with the product. Intelligent Harvest Systems will pay for factory specified replacement parts to correct non-cosmetic defects in materials or workmanship in that prevent function of this machine and that existed when this machine was purchased.

90 DAY LIMITED WARRANTY (PARTS AND LABOR)

(ALL PARTS)

For the first 90 days from the date of original purchase, when this machine is operated and maintained by the original owner and not for rental purposes. The machine must be used and maintained according to the instructions attached to or furnished with the product. Intelligent Harvest Systems will pay for factory specified replacement parts to correct non-cosmetic defects in materials or workmanship in that prevent function of this machine and that existed when this machine was purchased.

RENTAL HOUSE APPLICATION

ONE YEAR LIMITED PARTS ONLY WARRANTY (LABOR NOT INCLUDED)

In the first year from the date of original purchase, when this bucker is rented out, Intelligent Harvest Systems will pay for factory specified replacement parts only to correct non-cosmetic defects in materials or workmanship in these parts that prevent function of this machine and that existed when this machine was purchased. This is a limited one-year warranty on parts only and does not include repair labor. All belts are still limited to 90 days.

YOUR SOLE AND EXCLUSIVE REMEDY UNDER THIS LIMITED WARRANTY SHALL BE PRODUCT REPAIR AS PROVIDED HEREIN.

Service must be provided by Intelligent Harvest Systems when available. This limited warranty is valid only in the United States or Canada and applies only when the bucker is used in the country in which it was purchased. This limited warranty is effective from the date of original consumer purchase. Proof of original purchase date is required to obtain service under this limited warranty.

WHAT IS NOT COVERED

1. On-premises instruction on how to use your product.
2. Service to correct improper product maintenance or use, use on the incorrect electrical service. (e.g., wrong supply voltage, unstable power from generator).
3. Dulling of cutting dies. (These are considered a consumable but can be resharpened).
4. Defects or damage caused by the use of non-genuine Intelligent Harvest Systems parts or accessories.
5. Conversion of voltage of the machine.
6. Damage from accident, misuse, abuse, fire, floods, acts of God, or use with products not approved by Intelligent Harvest Systems.
7. Repairs to parts or systems to correct product damage or defects caused by unauthorized service, alteration, or modification of the machine.
8. Cosmetic damage including scratches, dents, chips, and other damage to machine finishes, unless such damage results from defects in materials and workmanship and is reported to Intelligent Harvest Systems within 30 days.
9. Discoloration, rust, or oxidation of surfaces resulting from caustic or corrosive environments, including, but not limited to, high salt concentrations, high moisture or humidity, or exposure to chemicals.
10. Improper Transport. This machine must be properly secured when transported in a vehicle.
11. Return shipping for repairs if necessary.
12. Service or parts for machines with original model/serial numbers removed, altered, or not easily determined.

The cost of repair or replacement under these excluded circumstances shall be borne by the customer.
